

## ONE HUNDRED AND NINETEENTH ANNUAL REPORT OF THE PRISONERS' AID ASSOCIATION OF NEW SOUTH WALES (INC.) PRESENTED AT THE ANNUAL GENERAL MEETING, LEVEL 1, 85 WILLIMA STREET, DARLINGHURST, 16thst DECEMBER 2019 BY THE PRESIDENT

Members and guests, welcome to the 119<sup>th</sup> Annual General Meeting of Prisoners' Aid.

2018-19 has been a year of consolidation. Indeed, Prisoners' Aid Association of NSW (PAA NSW) and its Social Enterprise 'Mates on the Move' have delivered good solid results.

Our relationship with our core funder Corrective Services NSW (CS) and PAA NSW has gone from strength to strength. The level of information sharing and working in partnership to deliver quality services has been strong. We have delivered quality services across 11 correctional centres supporting over 400 people in custody. PAA NSW's staff flexibility are making us cost effective in delivering our services.

'Mates on the Move' (MotM), our Social Enterprise which launched in November 2016, has delivered more consistent results to bring it to an expected break-even point by June 2020. It was a great honour for Mates on the Move to be a recipient of a Bronze Award in the 2018 Australian Institute of Criminology, Australian Crime and Violence Prevention Awards.

Our goals in 2018/2019 differed from previous years to solidify the financial position of the association. I am proud to say we have yielded good outcomes. These objectives were:

- 1. Focus on key strategic areas
- 2. Deliver surplus on the CS contract
- 3. Consolidate 'Mates on the Move' and
- 4. Strengthen our funding.
  - 1. Key strategic focus for the board for this year has been:

- Strengthening board governance and transparency in how we operate - The board secretary Lauren Osbich has continued to do impressive work which was confirmed by a review of our constitution by an external party, Justice Connect in November 2019.
- Strengthen the relationship with CS this has continued this year with the highest number of collection and referrals to date. CS are happy with the cost effectiveness and consistent quality of services provided.
- Develop MotM Due to funding constraints it has been decided to both:
  - Stop the training component until funds could be allocated to launch the next set of training.
  - o focus the energy of the board on supporting MotM to breakeven as soon as possible. This has been partly done with an increase in turn-over of 34% from the previous year and it is expected that by June 2020 MotM will break-even.
- Information Technology (IT) has finally been delivered on two fronts:
  - A new logo and website for PAA and MotM. These were launched officially at the fundraising dinner on the 31<sup>st</sup> of October. We would like to thank 'Divided by Zero' a marketing agency which, pro-bono, has supported us with what is viewed as a modern and contemporary logo and website.
  - Migration of all the accounting to XERO, an online software that gives both PAA and MotM the flexibility they need to deliver cost effective and timely service.

#### 2. Delivery of surplus on the CS contract:

- This has again been delivered this year due to the quality relationship with CS and the consistent work from Craig Baird manager of PAA NSW and his team.
- An additional 12 month contract has been signed with CS.

 Referrals and collections have grown consistently. This is important as it supports those released to re-establish themselves in the community and reduce recidivism

#### 3. Consolidation of 'Mates on the Move':

- Lois Dillon manager of the social enterprise has been a key person in getting us on track to breaking even by June 2020.
- MotM regular contract with Mirvac has grown. Mirvac has been very supportive within the industry with other organisations to promote the quality and cost effectiveness of our services.
- MotM numbers this year:
  - Total income \$184,470
  - This income is in part from Mirvac with a turnover of \$109,394
     with an increase on previous year of 13% and removals with a turnover of \$75,075 with an increase on previous year of 26.5%
  - Operationally this is 178 removals jobs which is an increase of 51% year on year.
  - MotM due to the consistency of work now employs its first permanent employee. This permanent employee has come from the original training program run by MotM.
  - 15 people have been employed on a casual basis. Currently, the social enterprise has 5 people working weekly on a casual basis. Overall MotM has paid employees the equivalent of 3595 hours of paid employment.

#### 4. Funding:

- Funding was and still is a key priority for the board and as such we have now retained the services of David Puls as a consultant in this space.
- PAA has had its first fundraising dinner on Thursday 31<sup>st</sup> of October. It
  was held at the Westpac boardroom in Barangaroo. This was
  delivered under the patronage of the Honourable John Dowd AO QC
  and the Honourable Michael Kirby AC GMC with the attendance of
  the Honourable Gladys Berejiklian MP Premier of New South Wales.

At this fundraiser \$37500 was raised through both donations and tickets sold. The board, the PAA and MotM team and David Puls have done an amazing effort to get this successful evening of the ground.

• During the 2018/19 year we received grants from:

Westpac Foundation \$10,000 Club Grants \$15,000

Roger West, past Chair and long term board member, has resigned from the board. His contribution during his time on the board has been exemplary and to me personally a strong mentor. Roger, thank you for your vision and support.

I want to place on record my sincere thanks to our two managers Lois Dillon and Craig Baird and our welfare worker, Jane Pappas. In addition to the paid workers and volunteers supporting PAA NSW and MotM.

I also want to thank my Board colleagues Lauren Osbich, Margaret Anderson, Frank Burke, Marty Bowen, and departed board member Roger West. They have been a great source of advice and support to Lois and Craig through this time. The collective intelligence demonstrated by this small group of dedicated people is second to none.

Finally, the generous support of donors is also essential and in particular we would like to thank the Milton Foundation and the Westpac Foundation.

#### Manager's Report

The 2018/19 year proved to be yet another successful year for Prisoners Aid. The Inmate Property Service (IPS) continues to grow as does Mates on the Move, our social enterprise.

The success of the IPS is largely due to Jane Pappas, our Welfare Worker. Jane stays on top of all referrals and manages communication with correctional centres, police, FACS Housing, private landlords and the myriad of other people in the community that we deal with in regards to an inmate property. Referrals are now consistently reaching 100 per quarter and we currently store property for over 400 inmates. These numbers reflect the need for this practical service. Referrals are only accepted where an inmate has no family or other community links that can assist with the storage of their belongings, and so assists some of the most vulnerable in the community. The return of an inmate's personal belongings to them after release is of both practical and psychological benefit to their successful return to the community.

Mates on the Move continues to increase its profile in the marketplace. There has been a significant rise in invoicing and hours worked by our employees. All employees of Mates on the Move are ex- offenders. The opportunity to work decreases significantly their propensity to re-offend whilst providing them with the increased choices that additional income brings. They are all paying tax and have less reliance on welfare, which is of great benefit to the community. Lois Dillon has done a magnificent job bringing this all together. Running a small business is never an easy job, but also catering to the social welfare needs of employees makes Lois's role particularly demanding. David Puls (consultant) has also assisted greatly throughout the year.

Community organisations like Prisoners Aid are nothing without the personalities, skills and input of the people behind the scenes. I would like to thank our board, Tim, Margaret, Lauren, Frank and Marty. Your knowledge, skills and senses of humour are a huge part of the success of the Association. I appreciate your support.

Lois and Jane have performed their roles exceptionally again this year. The Association is fortunate to have them as employees. They are professional, reliable and understanding of the circumstances of our clients. David's work on a consultancy basis has also added value to our capacity and services.

Bill and the Mates on the Move removals/recycling crew have contributed greatly to a successful year for Mates on the Move. Thank you for your efforts. 2019 / 2020 I am sure, will bring with it much success and many challenges. I am confident the team can capitalise on the successes and effectively deal with the challenges that will inevitably confront us.

#### Mates on the Move

Mates on the move has completed its second full year of trading with a total income of \$185,470.66 an increase of \$46,172.66 (34%) on the previous financial year. We have seen support for our social enterprise grow significantly from community organisations and charities. MOTM has increased the amount of removal jobs to 178 compared to 86 the previous year. Total revenue for removals \$76,075.82. The Mirvac contract has increased by 13% to \$109,394.84; Mirvac contact Kim Host has consistently been looking for opportunities to expand our contract and provide other work opportunities.

Number of paid employee hours increased to 3595 hours which equates to approximately \$100,000. MOTM employed its 1st permanent employee Bill Galea on a contract of 50 hours per fortnight. This gave Bill more security in his employment. A total of 15 people worked in the last financial year, as the year progressed, we focused on meaningful hours of employment for a group of 5-6 employees rather than sharing the work too much amongst a large group.

Our aim is to create opportunity to make a significant difference to the lifestyles of our employees. One employee was able to move from a boarding house to more stable accommodation at the Common Ground. One employee left to go into fulltime employment after working 12 months with MOTM. This employee credits MOTM with helping him successfully gain his confidence to return to mainstream employment.

Whilst the business has grown financially to become closer to breakeven point, there is still much work needed to become a successful social enterprise. As the removals work increased, it is clear we needed to focus on creating income streams that are more reliable and regular like the Mirvac contract. Kim Host from Mirvac became a great mentor and teacher regarding waste diversion. The focus for my year was to gain knowledge and understanding of the waste industry.

January 2019 was the start of communications with other none Mirvac buildings regarding expanding our coffee cup and paper towel collection. Systems Connect, a joint venture between CPB and UGL enquired about potentially using our services once they relocate to 116 Miller St North Sydney. Creating an account for disposal of waste from our own collections was necessary. Initially we had been disposing the Mirvac waste at a Suez transfer station, however after a fire at Chullora we transported the waste directly to

ResourceCo. ResourceCo is a processed engineered fuel (PEF) waste facility, which grinds PEF waste (including coffee cups and paper towels) into large fire blocks and sells these to Boral and other cement manufacturers for use in their kilns.

It was communicated to me that getting an account at ResourceCo was close to impossible. ResourceCo had rejected accounts for big companies such as Bingo Industries, WestConnex and only dealt with the primary customers Cleanaway and Suez. After months of communication, ResourceCo finally agreed to supporting our social enterprise by giving MOTM an account with an unlimited minimum disposal amount.

This development of having a waste outlet permitted us to actively pursue collections. In May, Investa Property Group contacted regarding trialling paper towel collections from 126 Phillip Street Sydney. Kim Host joined the initial meetings with Investa, I thank Kim for her commitment and enthusiasm regarding promoting the MOTM services. Talks are continuing with Systems Connect and Investa regarding starting trials in the next financial year.

The last financial year created MOTM the opportunity to build a strong network of waste contacts. Key relationships with ResourceCo, Foresight Environmental a significant waste auditor and relationships with many contacts from Social Traders such as Lendlease, CPB and Westpac.

Westpac sponsorship provided opportunity to attend the Change Makers Summit and The Westpac Leadership program. This led to further workshops and training courses through presenters from the Summit. I thank Westpac for their sponsorship and training. I would also like to thank The Milton Corporation Foundation who also donated generously to the Mates on the Move project.

This was my first year as the Social Enterprise Operations Manager for MOTM, as such there were a significant amount of learning in my new role. I thank Craig Baird for his outstanding support, training and encouragement over the past year. Thank you also to David Puls who provided much needed support over the past 12 months. I thank the Board for having faith to appoint me to the role of Social Enterprise Operations Manager and for supporting me in this role. I thank Bill Galea and team of casuals at MOTM for their hard work with the project. Thank you to Kim Host from Mirvac for her education and

knowledge sharing on waste. I look forward to growth and expansion of the project in the next financial year.

#### Note 1. Significant accounting policies

The principal accounting policies adopted in the preparation of the financial statements are set out below. These policies have been consistently applied to all the years presented, unless otherwise stated.

#### New or amended Accounting Standards and Interpretations adopted

The incorporated association has adopted all of the new or amended Accounting Standards and Interpretations issued by the Australian Accounting Standards Board ('AASB') that are mandatory for the current reporting period.

Any new or amended Accounting Standards or Interpretations that are not yet mandatory have not been early adopted.

#### **Basis of preparation**

In the officers' opinion, the incorporated association is not a reporting entity because there are no users dependent on general purpose financial statements.

These are special purpose financial statements that have been prepared for the purposes of complying with the Australian Charities and Not-for-profits Commission Act 2012 and New South Wales legislation the Associations Incorporation Act 2009, the Charitable Fundraising Act 1991 and associated regulations. The officers have determined that the accounting policies adopted are appropriate to meet the needs of the members of Prisoners' Aid Association of New South Wales Inc.

#### Historical cost convention

The financial statements have been prepared under the historical cost convention.

#### Critical accounting estimates

The preparation of the financial statements requires the use of certain critical accounting estimates. It also requires management to exercise its judgement in the process of applying the incorporated association's accounting policies. The areas involving a higher degree of judgement or complexity, or areas where assumptions and estimates are significant to the financial statements, are disclosed in note 2.

#### Revenue recognition

Revenue is recognised when it is probable that the economic benefit will flow to the incorporated association and the revenue can be reliably measured. Revenue is measured at the fair value of the consideration received or receivable.

#### **Donations**

Donations are recognised at the time the pledge is made.

#### Grants

Grants are recognised at their fair value where there is a reasonable assurance that the grant will be received, and all attached conditions will be complied with.

#### Interest

Interest revenue is recognised as interest accrues using the effective interest method. This is a method of calculating the amortised cost of a financial asset and allocating the interest income over the relevant period using the effective interest rate, which is the rate that exactly discounts estimated future cash receipts through the expected life of the financial asset to the net carrying amount of the financial asset.

#### Other revenue

Other revenue is recognised when it is received or when the right to receive payment is established.

#### Note 1. Significant accounting policies (continued)

#### Income tax

As the incorporated association is a charitable institution in terms of subsection 50-5 of the Income Tax Assessment Act 1997, as amended, it is exempt from paying income tax.

#### **Current and non-current classification**

Assets and liabilities are presented in the statement of financial position based on current and non-current classification.

An asset is classified as current when: it is either expected to be realised or intended to be sold or consumed in the incorporated association's normal operating cycle; it is held primarily for the purpose of trading; it is expected to be realised within 12 months after the reporting period; or the asset is cash or cash equivalent unless restricted from being exchanged or used to settle a liability for at least 12 months after the reporting period. All other assets are classified as non-current.

A liability is classified as current when: it is either expected to be settled in the incorporated association's normal operating cycle; it is held primarily for the purpose of trading; it is due to be settled within 12 months after the reporting period; or there is no unconditional right to defer the settlement of the liability for at least 12 months after the reporting period. All other liabilities are classified as non-current.

Deferred tax assets and liabilities are always classified as non-current.

#### Cash and cash equivalents

Cash and cash equivalents includes cash on hand, deposits held at call with financial institutions, other short-term, highly liquid investments with original maturities of three months or less that are readily convertible to known amounts of cash and which are subject to an insignificant risk of changes in value.

#### Trade and other receivables

Other receivables are recognised at amortised cost, less any provision for impairment.

#### Property, plant and equipment

Plant and equipment is stated at historical cost less accumulated depreciation and impairment. Historical cost includes expenditure that is directly attributable to the acquisition of the items.

Depreciation is calculated on a straight-line basis to write off the net cost of each item of property, plant and equipment (excluding land) over their expected useful lives as follows:

Motor vehicles 5-7 years
Office equipment 3-5 years

The residual values, useful lives and depreciation methods are reviewed, and adjusted if appropriate, at each reporting date.

An item of property, plant and equipment is derecognised upon disposal or when there is no future economic benefit to the incorporated association. Gains and losses between the carrying amount and the disposal proceeds are taken to profit or loss.

#### Trade and other payables

These amounts represent liabilities for goods and services provided to the incorporated association prior to the end of the financial year and which are unpaid. Due to their short-term nature they are measured at amortised cost and are not discounted. The amounts are unsecured and are usually paid within 30 days of recognition.

#### **Employee benefits**

#### Short-term employee benefits

Liabilities for wages and salaries, including non-monetary benefits, annual leave and long service leave expected to be settled wholly within 12 months of the reporting date are measured at the amounts expected to be paid when the liabilities are settled.

#### Note 1. Significant accounting policies (continued)

#### Other long-term employee benefits

The liability for annual leave and long service leave not expected to be settled within 12 months of the reporting date are measured at the present value of expected future payments to be made in respect of services provided by employees up to the reporting date using the projected unit credit method. Consideration is given to expected future wage and salary levels, experience of employee departures and periods of service. Expected future payments are discounted using market yields at the reporting date on national government bonds with terms to maturity and currency that match, as closely as possible, the estimated future cash outflows.

#### Goods and Services Tax ('GST') and other similar taxes

Revenues, expenses and assets are recognised net of the amount of associated GST, unless the GST incurred is not recoverable from the tax authority. In this case it is recognised as part of the cost of the acquisition of the asset or as part of the expense.

Receivables and payables are stated inclusive of the amount of GST receivable or payable. The net amount of GST recoverable from, or payable to, the tax authority is included in other receivables or other payables in the statement of financial position.

Commitments and contingencies are disclosed net of the amount of GST recoverable from, or payable to, the tax authority.

#### New Accounting Standards and Interpretations not yet mandatory or early adopted

Australian Accounting Standards and Interpretations that have recently been issued or amended but are not yet mandatory, have not been early adopted by the incorporated association for the annual reporting period ended 30 June 2019. The incorporated association have assessed that this will not have a significant impact to the association.

#### **Economic Dependence**

We noted that the Funding Agreement with the Department of Justice Corrective Services (NSW) will expire on 30 June 2020. Management is currently in the process of negotiating further extension to 30 June 2021.

#### Note 2. Critical accounting judgements, estimates and assumptions

The preparation of the financial statements requires management to make judgements, estimates and assumptions that affect the reported amounts in the financial statements. Management continually evaluates its judgements and estimates in relation to assets, liabilities, contingent liabilities, revenue and expenses. Management bases its judgements, estimates and assumptions on historical experience and on other various factors, including expectations of future events, management believes to be reasonable under the circumstances. The resulting accounting judgements and estimates will seldom equal the related actual results. The judgements estimates and assumptions that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities (refer to the respective notes) within the next financial year are discussed below.
